To obtain a Michigan Medical Marijuana Card the state law requires that you either:

A. Provide the doctor with medical records/documents relevant to at least one of your qualifying conditions *or*

**B. Establish records with SOHAI by:**

1. Completing a pre-exam at your appointment today with our qualified health care practitioner
2. Return for a 3 month follow up visit
3. Return for a 6 month follow up visit

(each visit is \$40)

The purpose of these visits is to monitor how your medicine is working for you and to establish a bona fide 'doctor-patient' relationship. This is in accordance with **MI State Law MMA333.26423(a)(1)(2)(3) EFFECTIVE APRIL 1, 2016 Act No. 512**. Completing your 3 visits ensures your card is fully legal and validated if ever investigated or audited.

Once you complete your 3 visits your records will be permanently established with SOHAI no matter how many times you renew!

If you can provide SOHAI with relevant medical records within 30 days you can waive the 3 and 6 month follow up visits.

MMA333.26423(a)(1)(2)(3) EFFECTIVE APRIL 1, 2013 Act No. 512

Sec. 3. As used in this act:

- (a) "Bona fide physician-patient relationship" means a treatment or counseling relationship between a physician and patient in which all of the following are present:
  - (1) The physician has reviewed the patient's relevant medical records and completed a full assessment of the patient's medical history and current medical condition, including a relevant, in-person, medical evaluation of the patient.
  - (2) The physician has created and maintained records of the patient's condition in accord with medically accepted standards.
  - (3) The physician has a reasonable expectation that he or she will provide follow-up care to the patient to monitor the efficacy of the use of medical marihuana as a treatment of the patient's debilitating medical condition.
